We have 5 big goals in our plan.


Every goal has actions.

Actions are things we will do to reach our goals.




Goal 1 We will make accessible services for people with disabilities

#### Actions



We will make it easier to access our buildings and services.



For example, we will have

• ramps



• communication boards



• disability awareness training for our staff.



We will make it easier to access our information.

For example, we will have information in

- Easy English
- Auslan or sign language.



We will make it easy to access information on our website.



We will train our staff to write information that is easy to understand.



We will make it easier for people with **intellectual disabilities** to access our services.

People with intellectual disabilities might find it hard to learn and do everyday activities.



We will make it easy for people with disabilities to be part of our events and activities.



We will follow laws about disability access and inclusion.

We will make it easy to access information about our legal cases.



## Goal 2 We will employ more people with disabilities

#### Actions

We will



 give work experience to students with disabilities



 give the right supports to people with disabilities



 train staff to give people with disabilities equal job opportunities.



We will train our managers and staff in disability awareness.



We will send job ads to our **Disability Reference Group**.

Disability Reference Group means people who

• know about disability



• give us ideas about disability inclusion.



We will make it easier to read our **policies** and procedures.

Policies and procedures are rules about how we work.



Goal 3 We will help people with disabilities to understand the law

#### Actions




We will train disability advocates about
